**Course Overview:**

In this course we will examine the fundamental concepts of international finance including: globalization, the international monetary system, the foreign exchange market and exchange rates, management of transaction an economic exposure, and international capital budgeting. Emphasis will be placed on learning the fundamentals of international finance and their application to managerial decisions.
